You'll find full details about the program below. To join All Class Plan, simply fill out the enrollment form on page 2, attach a voided check (or write in your bank account info), and bring it to the studio on your next visit.

All Class Plan terms and conditions

6-month minimum term of enrollment.

No holds or cancellations are permitted during the first six months of your All Class Plan participation, unless you become pregnant (doctor's note required) or are moving out of the Twin Cities (proof of new address required). After the first six months, your All Class Plan participation will continue on a month-to-month basis.

Payment info.

On or about the 1st of each month, a \$59 auto-payment will be processed from your bank account on file with the Yoga Pioneers. As long as you remain continuously enrolled in All Class Plan, this rate will not increase. You may change your bank account on file at any time; please allow five business days for processing.

Hold option.

You may put your All Class Plan participation on Hold up to once per calendar year, for *either* one calendar month or two consecutive calendar months. Taking a Hold preserves your continuous enrollment status (which you'd lose by canceling). Hold requests must be received on or before the 20th of the current month to begin the next month. Cancellation.

You may cancel your All Class Plan participation once you have met the 6-month minimum term of enrollment, either by phone (952.888.9642) or email (yoga.pioneers@outlook.com). **Cancellation notice must be received on or before the 20th of the current month to be effective as of the next month.** Cancellation requests received after the 20th incur a \$10 late-processing fee, unless monthly payment processing has already occurred. If it has, cancellation will be effective on the 1st of the month *after* next, and you will incur one final \$59 auto-payment.

Re-enrollment.

If you wish to re-enroll in All Class Plan after cancellation, you may do so subject to the program's capacity limits. Your re-enrollment will be at the monthly rate and for the minimum term of enrollment in effect at the time.
